VINEYARD CERTIFICATION

FAST TRACK	The traditional vineyard certification path requires LIVE membership for two growing seasons. However, vineyards may earn certification for the current vintage by reporting for this and last season, and paying two years dues and inspection fees in advance. IMPORTANT: The vineyard must be in full compliance for both years to qualify for certification.
